POTENTIAL HEALTH EFFECTS

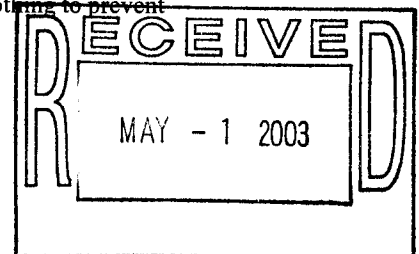
4. FIRST AID MEASURES
